RICHMOND WALKER

AUTHOR OF THE 24 HR. A DAY BOOK By Thomas K.

Richmond Walker (1892-1965) was born into a well-to-do family; his father served as the Speaker of the House of Representatives in Massachusetts from 1905-1907. After finishing school he ventured on a threemonth trip with a friend to Africa and his drinking career began. He married in 1922 and fathered three children, none of which slowed his drinking--in fact the opposite was true. In 1939 the couple separated which was a bottom for Walker and he joined the Oxford Group (Bill and Bob were members) and remained sober from 1939-1941. After one final relapse he took his last drink, joined A.A. in the Boston area and stayed sober until his death in 1965. Walker in the beginning took a back seat while his body healed from the ravages of alcohol but attended meetings on a regular basis and became more involved. He self-published his first book "For Drunks Only: One Man's Reaction To Alcoholics Anonymous" in 1945 (now available for purchase from Amazon) which gave his opinion of A.A. It was this book that laid the foundation for many of the thoughts recorded in "Twenty- Four Hours A Day." He began spending winters in Daytona Beach, Florida where he was active as a speaker. It was there he put his thoughts for the day down on paper, and with the encouragement of the local A.A. group began to self-publish his writings in 1948, using the county courthouse printer. He sold the book for \$1.50 and all the profits went to the group and the New York office of A.A. Sales of the book reached 600 per month and by 1953 they had increased even more. Walker, even with occasional help from his A.A. group, could no longer handle the task of filling all the orders. It was at this point that he offered the book to G.S.O. for publishing, cost free. In addition he offered \$2000 to help get them started. He urged people to write letters to New York encouraging them to publish the book but to no avail. There was talk from the General Conference in 1954 that a precedent for publishing outside material would be set, and objections were raised about the spiritual nature in the book (a lot of references to God). In the end it was refused. This may have been due to the fact that they had just published "Twelve Steps and Twelve Traditions." There was a warehouse full of them and they weren't selling. Also Ed Jurgen's "Little Red Book," was published around the same time. The debate over the decision still continues today. Patrick Butler, founder of Hazelden, approached Webster at this time and gained permission to publish after the refusal from the G.S.O. Walker and Butler didn't get off on solid footing with the first printing. The book was originally called "The Little Black Book" and Butler printed the first run with green covers! Walker objected and the color was quickly changed to black. Think of the value of your book today if you have a green-covered one! Today the sales of the Twenty-Four Hour book have reached 10 million copies, making it the second-most-read book after the Big Book, It is available in paperback, the original hard copy, small and large and in many different languages. Hazelden has just introduced a limited-edition book which details the making of the book. Included are photographs, reproductions of the original typed pages courtesy of the Daytona Beach group, a biography of Walker, and additional writings by the author in a luxurious coffee table edition. There may still be copies available through Hazelden, Amazon, or other booksellers. If you're interested in the history of alcoholism like this writer is you'll find no fault and would treasure this in your collection of books. Since only 1000 copies were printed (although more could come) I would not delay in seeking out a copy. You won't be disappointed.

Chuck C.'s Testimony Before a U.S. Senate Subcommittee

Part I

Chuck C., a well-known early AA member in California, testified before the Alcoholism and Drug Abuse Subcommittee in Los Angeles on Saturday, September 27, 1969. This is his testimony which I have copied from the official hearing records:

Present: Senators Hughes, (presiding), Dominick, and Saxbe [members of the Subcommittee]. Also present: Senators Cranston and Murphy [both Senators from California].

* * * * * *

Senator Hughes. For the next witness, I want no television, no pictures taken of the witness at all, because it's the witness's desire there be none. Once before a witness's anonymity was broken before this subcommittee, so I'll ask all members of the press, radio, and television please to respect the identity of this man and no photographs. He can state his own preferences about what he says.

STATEMENT OF CHUCK C., RECOVERED ALCOHOLIC, MEMBER OF ALCOHOLICS ANONYMOUS.

Mr. Chuck C. Thank you, Senator Hughes. It's a privilege for me to come with you this morning. I feel rather like a fifth wheel, because the things have been pretty well covered already: But I appear in a little different capacity than any of the others this morning,

because I am Chuck C. and I am a member of Alcoholics Anonymous.

Through the program of Alcoholics Anonymous, applied to my own life, I haven't had a drink or a sedating or tranquilizing pill since January of 1946, for which I am very grateful.

Now, we in Alcoholics Anonymous think that alcoholism is a disease. You have heard it spoken of this morning several times as such. I think informed medical opinion throughout the country recognizes it as a disease. It is defined as a disease of twofold nature, an allergy of the body coupled with an obsession of the mind.

However, most of us, or many of us, think that there is a third factor. We think it's a living problem. We do not deny the allergy of the body or the obsession of the mind. I had them both. I tried for the last ten years of a 25-year drinking career to prove that I didn't have an allergy of the body or obsession of the mind. However, I knew nothing about them, because I knew nothing about the disease of alcoholism. I tried to beat this thing myself for the last 10 years of a 25-year drinking career; and I proved to myself conclusively that I do have both the allergy and the obsession.

Now with 24 years of sobriety, 25 years of drinking, and the time before I drank to look at, I believe that our problem is primarily a living problem, and that alcohol is pretty much a symbol of it or a symptom of it.
